WGNI'S "DELAWARE RIVER & BAY AUTHORITY AND AVELO AIRLINES" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WGNI ("Station"), 3233 Burnt Mill Drive, Wilmington, NC 28403, during available business hours Monday through Friday, on the Station website, www.WGNI.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WGNI "Delaware River & Bay Authority and Avelo Airlines" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 90 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 90 days. - 3. How to Enter –

Online: Visit the Station's website, www.WGNI.com during the Contest Period, click on the "Contest" link, click on the "Delaware River & Bay Authority and Avelo Airlines" Contest link, and complete an entry form. All entries must be received by 11:59 PM ET on Sunday, September 1, 2024, to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate, or misdirected registrations, all of which will be disqualified. - 4. **Winner Selection.** On or about 12:00 PM/ET on Tuesday, September 3, 2024, Station will select two (2) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
